#### **Payment**

Sponsorships and exhibit space are confirmed only upon receipt of a signed agreement and full payment.

#### **Cancellation Policy**

Written cancellation requests must be received at [info@aspneph.org](mailto:info@aspneph.org) by March 1, 2027.

- Cancellations received on or before March 1, 2027 will receive a refund less a \$100 processing fee.
- Cancellations received after March 1, 2027 will forfeit 100% of monies paid.

#### **Exhibit Space Assignment**
